

343rd Fall Continuing Sessions of PYM meeting the morning of Saturday, November 11th, 2023 held at Arch Street Meetinghouse and online via Zoom

The meeting began with worship.

Introductions. Clerk Melissa Rycroft opened the session and introduced herself and rising clerk Nikki Mosgrove, the recording clerks, Sally McQuail and Jim Herr and General Secretary Christie Duncan-Tessmer. Elders Bethann Morgan, George Rubin, Yelena Forrester, Ed Solenberger, Bob Dockhorn. Pastoral Care, Edy Nolan, George Salloom, Meg Barney, Carter Nash. Ushers, Kimani and Wendy.

Melissa Rycroft spoke about this hybrid Meeting; reminding Friends to be patient with folks who struggle with technology. On Zoom, you can chat to the tech host and the rising clerk. Please wait to be recognized if you wish to speak, both in person and on Zoom. Closed caption is turned on.

Meeting Reports.

Administrative council member John Marquette presented George Schaefer as the nominee to serve as clerk for the nominating council. Friends approved.

George Schaefer, clerk of Nominating Council, presented nominees to serve as representatives to FCNL (Friends Council on National Legislation) Friends approved.

FGC (Friends General Conference) nominees were approved.

FWCC (Friends World Committee for consultation) nominees were approved to serve as representatives.

Pennsylvania Council of Churches representative was approved.

Releases and completed terms were approved with gratitude.

The corrected Nominating report will be attached to these minutes.

The Implementation Path was presented by the General Secretary,

Christie Duncan-Tessmer: Where We Are: Christie shared highlights of the current implementation focus of the strategic directions we approved in 2014. The five strategic directions are: Connecting, belonging, witnessing, communicating and functioning,

Some examples of each are:

Connecting: Threads are the things that run through all of our meetings. Worship and Care, religious education, outreach, governance and stewardship. What can Friends do to welcome people to come into our meeting? Trust circles to get to know one another.

Belonging. Broadening and Deepening relationships. Help our whole yearly meeting move forward by listening to the spirit move among us. We seek to be meaningful to all age groups together. PYM supported meetings with technology.

Witnessing. Look for what we are led to do all together, as a spiritual community. Addresses racism and witnessing climate change. Create trust circles to help mitigate conflict. Share on Equity & Inclusion at the beginning of committee meetings. Move toward being carbon neutral in our monthly meetings.

Communicating. How the structure of PYM works together, sharing stories.

Functioning. Councils do the work of PYM, making sure that we are looking forward and have all the support we need to implement this structure.

Minutes were read, corrected and approved.

After a brief break, with urging from our clerk who appreciated the joyful noise in the room, we returned to consider the future of our implementation plan. This strategic plan helps us to carry out what God calls us to, continuously. These directions are for all of us. And the question becomes, how do we know we are doing this?

Now we want to know how to engage everyone and where we are going. Christie Duncan-Tessmer gave us some suggestions for each of the five directions.

We then broke into small groups for each of these directions. Each group had worksheets to consider and engage for 25 minutes. At the end of that time, none of us was ready to quit.

We took time for some announcements. Sean Connolly, executive director of the Arch Street Meeting House Preservation Trust, told us about updates being made to the Arch Street Meeting House exhibits. These were last updated in 1976. There will be a survey for members of PYM to provide input for this. Salvador Orellana, deputy general secretary of PYM, gave us a personal recollection to tell us how climate change directly affected him. He told us about the Playbook for Climate Action, and printed copies were distributed. Frank Barch told us that Friends General Conference Gathering, June 30-July 6, will be at Haverford College. Representing Sessions Coordinating Committee, Frank told us that we have a brief PYM annual session following the Gathering. There will be a slightly longer Continuing Sessions in Spring and Fall next year to make up for time lost with the shorter summer sessions. The overall time for meeting for business will remain the same in 2024.

Deb Hejl, one of 9 representatives to Friends Committee on National Legislation, gave us a report on the accomplishments of FCNL in its 80th year. She showed us a policy book that is

used to guide activities. Examples include peace building, violence interruption in cities, and currently urging a cease fire in Gaza. She urges us to have our Meetings choose priorities for FCNL for 2024. Deb told us the Legislative Policy Collaborative has been laid down. In response to a question, she told us FCNL asked Monthly Meetings to help set a policy on reproductive rights and abortion. There were 400 responses to this request and the policy will be provided at the annual meeting next week.

Clerk led us in a consideration of our ministry of lobbying. She told us about five things on which she heard agreement including a belief in the value of lobbying, and that no one should say they are lobbying for the yearly meeting, though the yearly meeting should not tell anyone or any meetings how to lobby or tell what to lobby for. There also were questions about the authority of the Administrative Council, and how much lobbying is acceptable for the yearly meeting. Clerk showed us an infographic to understand the policy about lobbying on behalf of PYM. A Friend asked that members of three collaboratives discuss the challenges expressed in the policy. A Friend told us he feels the PYM policy has not been understood. A Friend from the Legislative Policy Collaborative told us they have, in fact, understood the policy, but disagreed with it. Clerk proposed to call a meeting of people who hold this concern and to come back to Spring Continuing Sessions with their progress. This was approved. Clerk asked that those who want to be involved email her. There was also a document distributed by a Friend, which will also be available by email.

Minutes were read, corrected and approved.

The meeting concluded with worship.

Administrative Council Report: Nomination for clerk of Nominating Council

The Administrative Council is responsible for bringing forward a name for clerk of Nominating Council. We are pleased that George Schaefer has responded with warmth and enthusiasm to our invitation to serve.

George is a member of Abington Monthly Meeting and Abington Quarterly Meeting. He has been actively involved in Philadelphia Yearly Meeting for decades in a range of capacities including as the clerk of the committee on homelessness in the 1980s, clerk of his monthly meeting, and as staff for ten years with responsibilities for pastoral care and aging. George retired from staff nearly two years ago and so is eligible to serve in PYM governance (former staff must wait one year before serving in an appointed position in PYM). George has a deep understanding of Quaker faith and practice, of recognizing individual's gifts and of leadership in the manner of Friends. In addition, he knows many people in our community.

We recommend that George Schaefer serve as clerk of Nominating Council.



Items of agreement and unclarity regarding the Advocacy Policy

There was a called threshing session on October 5th on the advocacy policy. While there were some intense feelings expressed, there were a good number of things that Friends seem to agree on. Including:

- 1. Quakers should lobby and are encouraged to include their Quaker identity in their lobbying efforts. They should also tell others to lobby.
- 2. No individual or group should speak on behalf of the yearly meeting.
- 3. The yearly meeting, as a respected body that includes many meetings and individuals, has a responsibility to speak to elected officials about the Truth we hold and to advocate for their taking steps toward that Truth.
- 4. If the yearly meeting discerns that God is calling on the yearly meeting to lobby for a specific bill, and approves the decision to do so, we will be faithful to that discernment.
- 5. The yearly meeting does not have authority over monthly and quarterly meetings. In addition, were a monthly meeting to face IRS consequences as a result of lobbying, those consequences would not affect other monthly meetings or the yearly meeting. Therefore, the yearly meeting governance may provide advice and caution but is not in a position to tell meetings what to do about lobbying.

There were also a number of questions for which Friends do not have a shared understanding of the answers. Including:

- 1. What is the authority and responsibility of the administrative council?
- 2. What are the parameters regarding when communications of a group within the yearly meeting count as speaking for themselves and when they count as speaking for the institution of which it is a part?
- 3. What are the limitations of using PYM communication channels for advocacy and lobbying?
- 4. How much lobbying is acceptable?
 - a. What is PYM's tax status as a nonprofit church, how is that different from another non-profit and what does that mean about PYM groups' allowance for lobbying?
- 5. What is FCNL and its members allowed to do in PYM and its meetings?

A Plan for Implementation of the Strategic Directions

Background: The three councils reviewed a draft Implementation Plan at their September council retreat. There were positive responses, some suggestions, and a few stops. The suggestions and stops were related to *how* we move forward rather than to the paths themselves. One small group was concerned that the Direction area they were reviewing did not include a path related to encouraging interconnection between meetings; however that was, happily, covered in another Direction area.

As a result of the work at the retreat and feedback from council members at their October retreat, a new draft has been constructed that is quite simple and straight-forward.

Next steps: The PYM body, the councils and the staff can simultaneously engage in implementing our five strategic direction areas. We plan to move forward with three parallel streams of approach at the same time. Each of the three streams will make its own decisions for itself. The discernment and decisions of one stream may provide seasoning for other streams, but not instruction.

- 1. One stream is the **PYM body**. The presiding clerk will engage the body in responding to and seasoning the paths to provide direction for our yearly meeting. This process is expected to be stretch over several yearly meeting Sessions and will include outreach to monthly and quarterly meetings. This process meets multiple needs. It:
 - a) Engages all Friends and meetings in the work and ministry of PYM.
 - b) Responds to Friends' desire to be more actively engaged in the business and purpose of the yearly meeting.
 - c) Increases our opportunity to listen faithfully to God's direction for us as there is more involvement

This stream is guided by the presiding clerk.

2. One stream is the **PYM staff**. The staff will use the current destinations to formulate SMARTIE outcomes for the paths that will guide their work. SMARTIE outcomes are <u>Specific</u>, <u>Measurable</u>, <u>Achievable</u>, <u>Timebound</u>, <u>Inclusive</u> and <u>Equitable</u>.

This stream is guided by the General Secretary.

3. One stream is **PYM Governance**. The councils will use the Destinations to guide their work and agendas and the direction they provide to their committees.

This stream is guided by the council clerks and the councils themselves.

communications and technology.






Connect friends and meetings


Connect friends and meetings






(2) Have fearless conversations about race
